We started 2017 with hopes of reaching \$1 million in total grants from all Funds by the end of the year. We are happy to report that we achieved our \$1 million goal and more importantly, have granted over \$1 million to projects and programs in our wonderful community. Without you, none of this would be possible. Thank you for supporting the work of our Foundation.

In 2017, we continued to focus our attention on the Foundation's mission – enhancing the quality of life for the Bexley community through investing in initiatives that make a positive impact.

Highlights from the year include:

- 🍁 \$1 million in grants awarded in Bexley! Since 2011, we have awarded over 100 grants totaling over \$1,000,000 and ranging from \$500 to \$81,000.
- 🍁 Since 2011, we have received over 2,250 donations. Without you, none of this would be possible, THANK YOU!
- 🍁 The Bexley Farmers' Market Fund became our 11th Fund, supporting the annual Bexley Community Farmers' Market.
- 🍁 In October, 2017 the Foundation announced its first ever Capital Campaign to raise \$1,000,000 to support the City of Bexley's Jeffrey Mansion Project.

- (1) Contributions received by the Bexley Community Foundation are transferred into funds held and invested at The Columbus Foundation for our use. These funds are classified as Beneficial Interest in Assets Held by Others on our Statement of Financial Position and are subject to the variance power of the Board of Trustees of The Columbus Foundation.
- (2) During 2017, we awarded \$111,529 in grants and distributed \$167,555 for grants awarded in 2017 and prior years. Due to the timing of our grant cycles and other factors, all or part of a grant is frequently distributed subsequent to the year in which the grant is awarded. At December 31, 2017, \$307,838 of our total assets was designated for previously awarded grants in our various funds for distributions on outstanding grants.
- (3) During 2017, operating expenses were funded by contributions from our Board members, corporate gifts designated for that purpose and investment return on our funds at The Columbus Foundation. Event expenses were funded by contributions from event sponsors. Contributions from the public were used to fund grants.

Our statement of financial position as of December 31, 2017 and the related statements of activities and cash flows for the year then ended were reviewed by Wells, CPA LLC independent accountants, and copies of these statements and our federal tax return (Form 990) for 2017 are available upon request.

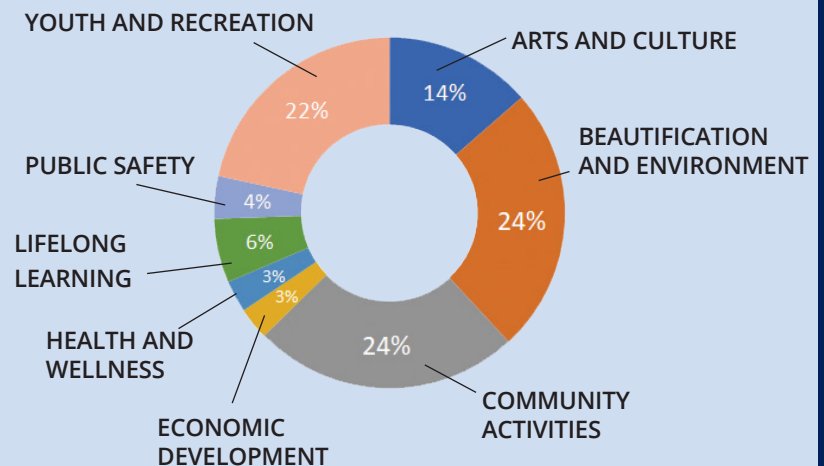

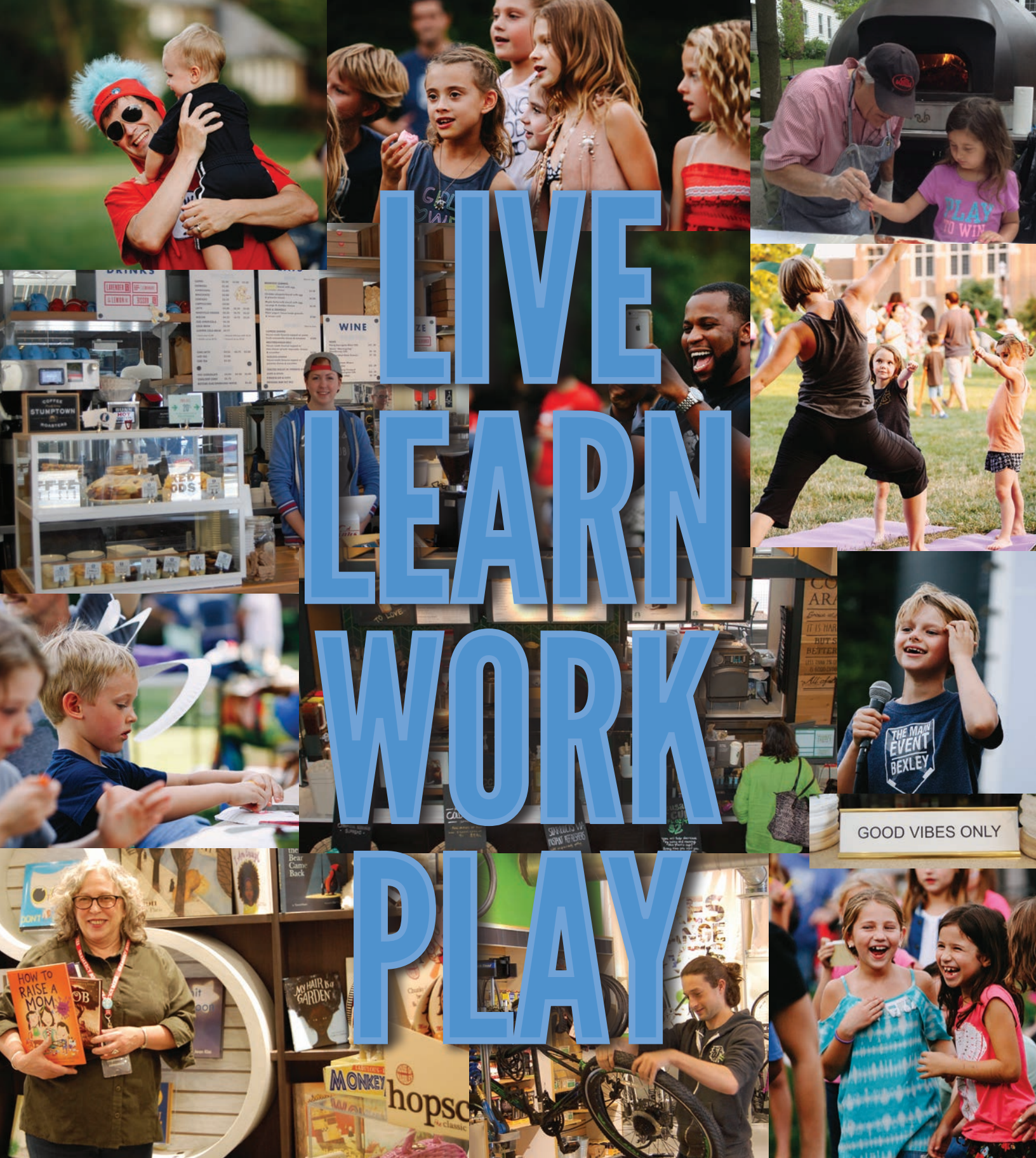

OUR FUNDS *Since 2011, we have grown to*

Bexley Community Fund

The Bexley Community Fund is our general purpose fund providing grants to a full range of Bexley projects and programs. The mission of this fund is to support the belief that Bexley is where we **live, learn, work and play**.

Bexley Beautification Fund

The Bexley Beautification Fund conducts two campaigns each year, Trees for Bexley and Bexley in Bloom, and invests in Bexley's urban forest, the physical environment and community beautification. Fund projects have included replacement trees throughout the City to preserve green areas in every Bexley neighborhood, gateways at the entrances to the community, plantings and lighting at Drexel Circle, trees in the Main and Broad Street medians, and flower baskets on Main Street, Cassady Avenue, and the Broad Street and Clifton Avenue bridges.

Youth and Recreation Fund

The Youth and Recreation Fund was created to benefit community-wide recreational efforts for the next generation of Bexley residents. An integral part of this fund is to support the City's Parks and Recreational programs including launching and supporting the annual Splish, Splash and Dash Youth Triathlon along with other recreation projects in our community.

Jeffrey Mansion and Park Fund

The Jeffrey Mansion and Park Fund is a special purpose fund for the maintenance and improvement of Bexley's treasured mansion and grounds. The Parkview Avenue entryway and brick sidewalks leading up to the mansion were sponsored by this fund. Annual gifts from designated donors sustain the Jeffrey Mansion and Park Fund.

Bexley Wellness Fund

The Bexley Wellness Fund is a special purpose fund devoted to activities, programs and services that promote community, family, and individual health in Bexley. The fund was created in 2014 by Beth Grimes-Flood and is funded by both donor gifts and grants from health and wellness organizations.

Bexley Public Library Community Author Series Fund

The Bexley Community Foundation teamed up with the Bexley Public Library in 2016 to establish the Bexley Public Library Community Author Series Fund. The mission of this fund is to provide literary experiences creating a lifelong love of learning in our community. Visiting authors such as Pulitzer Prize winners Colson Whitehead and this year's author, Elizabeth Strout, have shared their novels with the Bexley Community.

Denise and Barry Blank Tree Fund

The Denise and Barry Blank Tree Fund is a donor designated fund dedicated to the planting of trees throughout Bexley. The fund is supported by members and friends of the Blank family and other Bexley residents who love our National Tree City. Established in 2012, the fund has provided several plantings in Bexley such as trees on Cassady at Fair Avenue and landscaping at the new Cassingham Playground.

Anne and Sam Powers Fund

The Anne and Sam Powers Fund is a donor designated fund established in 2016 to promote positive sports experiences for youth who participate in school, recreational, and other sports programs serving our Bexley community. Grants from this fund also provide programming to help athletes, parents and coaches develop skills to improve their sports experiences.

Susie and Charlie Rath Creative Arts Fund

The Susie and Charlie Rath Creative Arts Fund is a donor designated fund established in memory of Susie's Father, Leland S. McClelland, a highly regarded local artist and longtime Bexley resident. The fund was established in 2015 to promote the creative arts, including the visual and performing arts, vocal and instrumental music, writing and communication, and design in our Bexley community.

Jay and Jeanie Schottenstein Family Fund

Established in 2015, the Jay and Jeanie Schottenstein Family Fund designates gifts to specific nonprofit organizations serving our community. Bexley has long been a charitable priority of the Schottenstein family and their family's support sustains the mission of the Foundation to live, learn, work and play in Bexley.

Bexley Farmers' Market Fund 🍁 NEW 2017

The Bexley Farmers' Market Fund was established to support our community Farmers' Market which runs weekly from May through October. Local farmers and community members come together to shop and socialize on Dawson just off Main Street celebrating our wonderful community.



OUR GRANTS 2017 *Our grants fund worthwhile*

BEXLEY COMMUNITY FUND

Safe Conversations about Race: The Bexley Public Library received \$3,000 for a three-part community program where community members engaged in an interactive discussion about race in a safe space.

Cassingham Playground Project: \$8,000 was awarded to install a new community playground at Cassingham Elementary. Additional funding was provided by our **Youth and Recreation Fund** (\$5,000) and the **Denise and Barry Blank Tree Fund** (\$10,000).



Recreation and Parks Department: A \$5,000 grant funded a new Park n' Play program. The Park n' Play program takes place at Jeffrey Park, the pool and elementary schools and provides a fun place for kids to spend time outside with camp counselors. Additional funding provided by our **Youth and Recreation Fund** (\$4,000).



Bexley Celebrations Association: A \$5,000 grant to the Bexley Celebrations Association supported this year's 4th of July Celebration. The Bexley Community Foundation was the Presenting Sponsor of the July 4th evening events on the lawn of Capital University.

Bexley Police Department: A grant was awarded to the Bexley Police Department to purchase fatal vision goggles which replicate the experience of driving under the influence.



Capital University: A \$5,000 grant helped underwrite an Active Aging Symposium on Capital's campus in March of 2017. The "Older But Bolder" program was funded in partnership with OhioHealth, The Ohio State University Wexner Medical Center and The Ohio State University Ross Heart Hospital. Additional funding provided by our **Bexley Wellness Fund** (\$5,000).

YOUTH & RECREATION FUND GRANTS

Bexley Boys Youth Lacrosse: The Bexley Boys Youth Lacrosse program received a grant of \$2,755 to purchase 30 helmets, goals and balls enabling the program to be expanded to include 1st and 2nd grade boys in our community.

Splish, Splash and Dash Youth Triathlon: The Bexley Recreation and Parks Department received a grant of \$1,000 for the fifth annual Bexley youth triathlon. This unique event, which had over 325 participants last year, was launched in 2013 with a grant from the Fund.

BEXLEY BEAUTIFICATION FUND

Gateway Plant Material: \$23,000 enhanced the plant material at the gateway at Broad Street and Westland Avenue. The project included installing a horn beam basque on the North and South side of Broad Street; planting wide swaths of boxwood and winter creeper; adding a pillar on the North of Broad and uplighting the entire gateway.

SUSIE AND CHARLIE RATH CREATIVE ARTS FUND

BexArts: The first grant from the Susie and Charlie Rath Creative Arts Fund awarded \$5,000 to BexArts for their inaugural season in summer of 2018 which included four major projects: 1) Three large scale murals, 2) A community theater production with musical interludes, 3) "Bexley Kindness Rocks" rock garden and, 4) A summer 2018 Community Arts Exhibition at the Bexley Public Library.



JAY AND JEANIE SCHOTTENSTEIN FAMILY FUND

Grants from the Jay and Jeanie Schottenstein Family Fund in 2017 supported the Bexley Historical Society, Bexley Women's Club, Bexley Celebrations Association, Cassingham Playground Project, Bexley Public Library, Bexley in Bloom and Trees for Bexley.

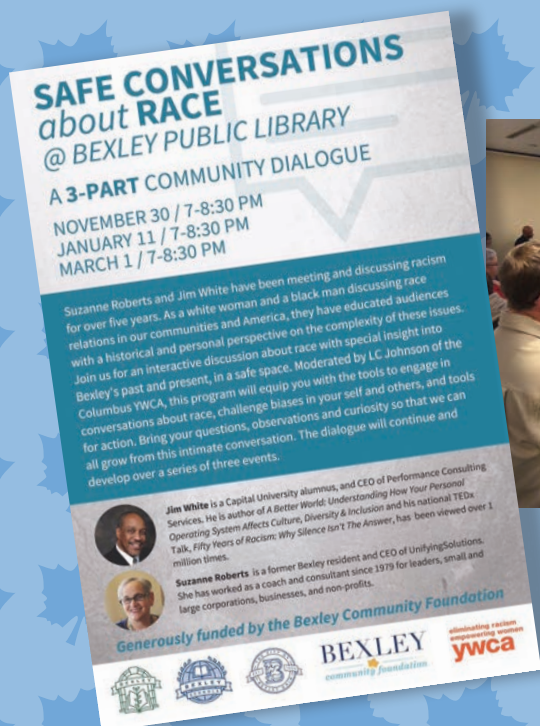

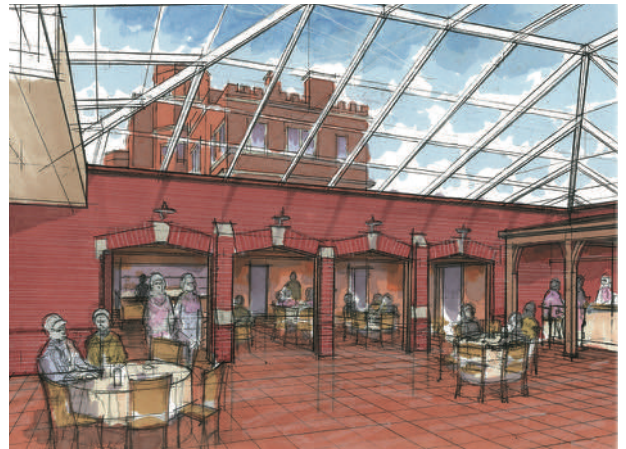

CAPITAL CAMPAIGN

The Bexley Community Foundation will conduct our first ever Capital Campaign to raise \$1 million to support the City's Jeffrey Mansion Project. The campaign will support the projected costs to upgrade the programming and event space at the Mansion. The new addition will be ADA accessible and provide room for the Jeffrey Mansion preschool and summer camps. These upgrades will make the Mansion a state of the art facility that will provide the best programming and event space to all residents of Bexley. THE CORNERSTONE AWARD

Susie and Charlie Rath

Fall 1963:

Susie and Charlie Rath met at Wentz's Pharmacy – now Graeter's on the corner of Drexel and Main Streets in Bexley, Susie worked the soda fountain and Charlie – a sales representative for The Upjohn Company, a Kalamazoo based pharmaceutical manufacturer – called on Roy Wentz, Jr. to assure that his store's inventory of Medicinals was adequately stocked.

"After meeting Susie, I found many reasons to visit Wentz's more frequently to be sure I hadn't overlooked a shortage of a critical medication such as Kaopectate," said Charlie.

Through the months ahead their relationship grew to the matrimonial stage and following an exhaustive investigation of football schedules for The Ohio State Buckeyes and The Fighting Irish of Notre Dame, it was determined that the only non-conflicting day for their wedding was Saturday, October 31, 1964 – Halloween Day.

After the arrival of their three children – Anne, Kate and Charlie (all BHS graduates) – the family moved into 2640 Brentwood Rd on December 28, 1970, where Susie and Charlie still live. "Raising our family in Bexley has been a wonderful experience," says Susie. "And still today – we love the experience, socializing with our friends and neighbors and being entertained by the assortment of joggers, dogs, families and children who parade by our house."



During those years, Susie has been a homemaker; Charlie, the Chief Marketing Officer for Wendy's International. According to Charlie, "Having the good fortune of proximity to our superior Bexley schools, our community amenities such as Jeffrey Mansion, the Drexel Theatre, Capital University, our fabulous library, the annual 4th of July celebration and the year-round good city management, brings to mind a Wendy's commercial with Dave Thomas in which, after the hamburger superiority was detailed, the question is asked, 'Given that, why would anyone go anywhere else?' And, as with the commercial's ungrammatical reply: "There Ain't No Reason," says Charlie.
